## **Re:** Compliance with United States Export Regulations

I (We) acknowledge that U.S. laws prohibits the sale, transfer, export, or re-export to or other participation in any export transaction involving U.S. products with individuals or companies listed in the U.S. Commerce Department's Table of Denial Orders, the Treasury Department's list of Specialty Designated Nationals, or the U.S. Department of State's list of individuals debarred from receiving Munitions List items.
- 4. I (We) will abide by all applicable U.S. export control laws and regulations for any products purchased from D3 Aviation, Inc. and will obtain any licenses or prior approvals required by the United States Government prior to export or re-export of U.S. products, software, or technology.
- 5. I (We) agree that the export control documents in items 1-4 above shall survive the completion, early termination, cancellation or expiration of the applicable purchase order, agreement, or contract. This certificate is valid indefinitely from the date of acceptance.
